### Adderbury Parish Council Report for February 2022

**Meetings** – During February 2022, a meeting of the Parish Council was held at Church House, High Street, Adderbury on Tuesday 15 February 2022. Copies of agendas and minutes are available on the PC web site. <a href="https://www.adderburypc.co.uk">www.adderburypc.co.uk</a>

**Parish Council Surgeries** – The next two surgeries are scheduled for the following dates, from 11am to 12 noon at Church House, High Street, Adderbury: Saturday 5 March 2022 & Saturday 2 April 2022.

**Vacancies** – There are three vacancies on the Parish Council and if residents would like information on becoming a Councillor, they should contact the Clerk or any of the current Councillors for more details.

**Environment** - Please could residents remember to cut back hedges and trees which are overhanging footpaths and roads, as this creates a dangerous situation for drivers and pedestrians.

**Highways** - The Parish Council has applied to the County Council for appropriate roads in the village, to have a 20mph speed limit restriction. Main roads such as the B4100, A4260 and Milton Road are exempt from the initiative. The application is supported by County Councillor Arash Fatemian.

The Parish Council would also be investigating further, the proposed closure for the western arm of the oak tree junction (Horn Hill Road/Milton Road). A resident had kindly come forward to support the Parish Council with this project and more details will follow in due course. Any residents who wish to be involved, should contact the PC Clerk.

### Residents of The Rise and parents dropping off/collecting from the Primary School are reminded not to park their vehicles on the green in The Rise, as it is an amenity area not a designated parking area. Parking on the green damages the grass, kerb stones and obstructs the grass cutting contractor from being able to maintain the grass.

For highways issues that do not require immediate action, residents are encouraged to use the Fix My Street app or complete an online form, available on the OCC web site.

Civil Parking Enforcement has been introduced by the County Council and it is hoped that officers will monitor the village for illegal parking. **New Benches** – New benches have been installed in the Cemetery and on the Green. The memorial bench in the Cemetery has been kindly donated to the Parish Council.

**Planning** - The Parish Council would be objecting to outline planning application 22/00203/OUT, submitted by Nicholas King Homes at land to the rear of St Marys House adj to Henge Close, Adderbury for the construction of up to ten houses, with all matters reserved except access. Residents are encouraged to comment on the application.

Three planning applications have been submitted to Cherwell District Council, applications 21/03266/F, 21/03267/OUT & 21/03268/OUT at Barnards House in Ardley for a new logistics site with access to the B4100. This could impact the traffic in Adderbury and the Parish Council would be reviewing the application and submitting comments, if necessary.
