Report for May 2020

Meetings - During May 2020, there was one meeting of the Parish Council held on Zoom on 19 May 2020.

There was also a meeting of the Environment Committee using Zoom on Tuesday 5 May 2020 at 7.30pm.

If anyone in the village needed support during the Covid-19 Pandemic, they should contact the Clerk who will help them contact the correct organisation.

Environment/Highways/Footpaths – The Community Speed Watch Scheme was currently on hold until the Government issued further advice on social distancing. However prior to this, volunteers had been using the Speed Indication Equipment supplied by Thames Valley Police and also the Sentinel fixed speed camera which had been purchased by the Parish Council. If anyone would like to support the village with this project, please contact the Clerk to the Parish Council.

Prior to the lockdown, drivers of speeding cars had been written to by Thames Valley Police; some of those drivers were local residents as well as some drivers from out of the area.

Three volunteers from West Adderbury had also come forward to work with the Parish Council to progress other traffic calming measures, including a chicane on Milton Road and the possible temporary closure of Oak tree corner. If any other residents wished to assist the Parish Council with the implementation of the speed reductions measures, they should contact the Clerk to the Parish Council. Unfortunately without the support of residents, the Parish Council does not have the capacity to introduce all of the measures it would like. The measures had been approved and costed by the Parish and County Councils and funds are available, we now need the man power to introduce them.

Drainage issues on Oxford Road had been followed up with the County Council. Some works had been completed; kerbing and patching work was still to be undertaken.

There has been a general increase in many areas of fly-tipping and if residents were aware of any, they should report it to Cherwell District Council.

Weed Control had been carried out in the road gutters in the village and the next treatment was due in September 2020.

It was agreed in principle that a Memorial Tree for Bryan Sheppard, could be planted in Colin Butler Green, to replace a tree previously cut down.

Adderbury Cemetery – The Cemetery in Hornhill Road was still open, but residents are requested to ensure that they observe social distancing guidelines when visiting the site.

Lucy Plckett Playing Field - Residents are asked to enjoy the facilities at the Lucy Plckett Playing Field, but if the litter bins were full, please could rubbish be thrown away at home and not left on the ground around the litter bins. Replacement 'no dog fouling' / dogs on lead signs would be erected in due course.

RESIDENTS ARE REMINDED THAT DOGS IN THE LUCY PLCKETT PLAYING FIELD SHOULD BE KEPT ON A LEAD AND THAT THEY ARE NOT PERMITTED IN THE PLAY AREA

Vacancy – There is currently two vacancies on the Parish Council and if anyone would like to become a Councillor, please email the Clerk for more information. The role is until the elections in May 2021 when the whole Parish Council is due for election. Elections had been due to be held in May 2020 but they had been put back a year due to the Covid-19 Pandemic.

VAS – The VAS on Banbury Road is currently not working and is due to be repaired.

Snow Wardens – If any residents would like to support the village and become a Snow Warden to clear and grit footpaths during the winter, please contact the Clerk to the Parish Council.

Adderbury Lakes – The Parish Council thanks all those who volunteer at the Adderbury Lakes Local Nature Reserve. The Lakes were currently closed due to the Covid-19 Pandemic and would re-open when Government guidelines on social distancing had been relaxed.

The Parish Council/Working for Adderbury Community project for Sports and community facilities on Milton Road – The planning application for phase two of the project, which was the design of the building, had been submitted to Cherwell District Council and would be considered at the Planning Committee in May 2020. Works to the pitches and drainage on the land had started and planning permission for this work had already been granted. Due to health and safety issues, the public were not now permitted to enter the field.

Annual Parish Meeting 2020 – This meeting had been cancelled due to the Covid-19 Pandemic.

Community Governance Review (CGR) – A petition from some residents living in West Adderbury had been submitted to Cherwell District Council requesting a CGR to enable West Adderbury to have a separate Parish Council. More details on this were available on the Parish Council web site and the Parish Council will keep all residents up to date on the consultation process.

Adderbury Fields – The communal areas on the site had not yet been transferred to Cherwell District Council, therefore, any issues relating to litter/dog waste bins and grass cutting should be directed to David Wilson Homes.

Play Areas – The play areas in The Rise and the Lucy Plackett Playing Field are both currently closed due to the Covid-19 Pandemic. Please do not enter the play areas until the Parish Council has advised that they are open again. The closures are due to the Government guidelines on social distancing.

Parish Council Surgeries – These are held on the first Saturday of the month, from 11am to 12 noon at the Church House, however, they are currently cancelled until further notice.

Land Registration – The Parish Council was continuing to pursue the registration of the railway embankment and the Lucy Plackett Playing Field. The issues with the track which runs alongside The Leys was now in the hands of the Parish Council's solicitor.

Adverse Weather - Oxfordshire County Council works closely with all its partners to monitor the situation in the case of bad weather. There are some numbers that you can call to report weather related issues if you become aware of them:

- To report fallen trees or other debris which pose a risk to your safety or the safety of others, please call 999
- To report fallen trees or other debris which doesn't pose such a high risk but still needs to be dealt with, please call 101
- If you lose power or can see that a power line has come down please report it by calling 105

- If you have a flooding emergency which is a threat to someone's life, contact Oxfordshire Fire and Rescue Service on 999

- If your property is at immediate risk of surface water flooding please contact Thames Valley Police on 101

Reminder: To dog owners, please ensure that all dog faeces are cleared up and either taken home (and placed in household waste green bins) or placed in the dog waste bins provided. Take extra care on grassed areas where children play.

Dogs must also be kept on a lead in the Lucy Plackett Playing Field and at the Adderbury Lakes Nature Reserve.
