Thank you for your request for information received on 07 November 2024. This request has been handled under the Environmental Information Regulations 2004.

**Your request**

Date range: 2000 – 2024

Adderbury Parish Council understands that OCC holds circa £278m of unspent Section 106 money. Please could you provide Adderbury Parish Council with the total amount of unspent Section 106 funds which have been allocated to Adderbury and state what the funds can be spent on. Thank you.

**Our response**

We can confirm the Council holds £857,989 allocated to Adderbury. £589,418.75 is allocated to education, £5,694.55 is allocated to adult learning, £32,254.06 is allocated to Countryside, £80,768.09 is allocated to libraries, £2,159.79 is allocated to the museum resource centre, £111,478.10 is allocated to highways and transport and £36,215.66 is allocated to waste & recycling centres.

Some of this funding is already allocated to projects that are in the capital programme, so although it has not yet been spent it is committed. The remaining funding is held to be used by the relevant service area in accordance with the wording of the legal agreement.

**Internal Review**

out the reasons why you are dissatisfied. Your request must be submitted within 40 days from the date we issued our initial response. We are not obliged to accept internal reviews after this date.
